RESOLUTION AUTHORIZING FILING OF APPLICATION WITH THE HOUSING AND HOME FINANCE AGENCY, UNITED STATES OF AMERICA, FOR A GRANT UNDER THE TERMS OF PUBLIC LAW 345, 84<sup>th</sup> CONGRESS, AS AMENDED BY THE PUBLIC WORKS ACCELERATION ACT

WHEREAS, under the terms of said Public Law 345, as amended, the United States of America had authorized the making of grants to public bodies to aid in financing the construction of specific public projects:

Now Therefore, Be It Resolved By the Board of Directors

- 1. That W. C. Newsome be and he is hereby authorized to execute and file an application on behalf of the Franklin County Water District with the Housing and Home Finance Agency, Unites States Government, for a grant to aid in financing the construction of lake on Big Cypress Creek.
- 2. That W. C. Newsome, President, be and he is hereby authorized and directed to furnish such information as the Housing and Home Finance Agency may reasonably request in connection with the application which is herein authorized to be filed.

Whereupon, Director D. O. Aldridge moved the adoption of the Resolution and Director Landon Ramsay seconded the motion. Upon the question being called, the Resolution was adopted by unanimous vote.

There being no further business at this time, the meeting was adjourned at 9:45 p.m.
