ON THIS, the 13th day of January, 1966, the Board of Directors of the FRANKLIN COUNTY WATER DISTRICT convened in special session at the regular meeting place thereof, in the Courthouse at Mount Vernon, Texas, with the following members present, to wit:

The President of the Board, Mr. W. C. Newsome, called the meeting to order, declared a quorum present, and that the meeting was duly convened and ready to transact business.

Mr. Art Postel met with the Board. At 1:30 p.m., the stime stated for the receiving of bids, none had been presented. It was suggested by Mr. Postel and agreed to by the Board that he would call the seven firms to whom notices were sent to see if they would be interested in making a bid at below par value. This was done and the following offers were made:

Bache & Company -98.02% of par value plus accrued interest Dallas, Texas

Weber, Hall Cobb & Caudle – 97.00% of par value plus accrued interest Dallas, Texas

Du Pont & Company & Goodbody – 98.27% of par value plus accrued interest Dallas, Texas

Landon Ramsay made the motion to accept the bid of 98.27% of par value plus accrued interest made by DuPont & Company & Goodbody. A. J. Laws seconded the motion, and upon the question being called, it carried unanimously.

The President presented to the Board of Directors a resolution awarding the sale of the \$100,000 "FRANKLIN COUNTY WATER DISTRICT BONDS, SERIES 1965", dated October 1, 1965. The resolution was read in full. Mr. Landon Ramsay moved that it be adopted. The motion was seconded by Mr. A. J. Laws, and, the question being called for, the resolution was passed and adopted by the following vote:

The President declared the resolution finally passed, adopted and enacted.

The RESOLUTION is as follows:

WHEREAS, at a meeting held on the 15th day of September, 1965, the Board of Directors of the FRANKLIN COUNTY WATER DISTRICT passed and adopted a resolution authorizing the issuance of \$100,000 "FRANKLIN COUNTY WATER DISTRICT BONDS, SERIES 1965", dated October 1, 1965, for the purpose of financing costs necessarily incurred in accomplishing purposes for which the District is created,

including incidental expenses involved in the engineers' preliminary work acquisition of land, organization, administrative and financing; and,

WHEREAS, it is now proper for the Board to award the sale of said bonds; now, therefore,

BE IT RESOLVED AND ORDERED BY THE BOARD OF DIRECTORS OF FRANKLIN COUNTY WATER DISTRICT:

THAT the aforementioned bonds are hereby sold to FRANCIS I. DUPONT & COMPANY AND GOODBODY & CO. at the price of 98.27% of par value plus accrued interest, all of such bonds to bear interest from their date to their respective maturity dates at the rate of 3-1/2% per annum. Delivery of the bonds shall be made to said purchaser as soon as bonds shall be made to said purchaser as soon as may be after the adoption of this resolution, upon payment therefore in accordance with the foregoing.

PASSED, APPROVED AND ADOPTED, this the 13 day of January, 1966.
