ON THIS, the 22nd day of April, 1967, the Board of Directors of the Franklin County Water District convened in session at the regular meeting place thereof in Woodrow Edwards Office at Mount Vernon, Texas, with the following members present:

and with the following absent: D. 0. Aldridge, constituting a quorum; and among other proceedings had were the following:

The President presented to the Board of Directors a resolution authorizing delivery of certain bonds of the Franklin County Water District. The resolution was read in full. Mr. Landon Ramsay moved that it be adopted. The motion was seconded by Mr. Horris Morris and, the question being called for the resolution was passed and adopted by the following vote:

AYES: Messrs. Newsome, Ramsay, Morris, and Laws.

NOES: None.

The President declared the resolution finally passed, adopted and enacted.

The RESOLUTION is as follows:

WHEREAS, this Board has heretofore authorized the issuance of **\$1,600,000** "FRANKI IN COUNTY WATER DISTRICT BONDS, SERIES 1966", dated December 1, 1966, and subsequently awarded the sale thereof to Postel Securities Company at the price of 102-1/4% of par value plus accrued interest to date of delivery; and

WHEREAS, it now appears to the best interest of this Board to provide for the delivery of only a portion of the authorized bonds at this time, and to provide for the safekeeping of the remainder of the bonds of said authorization pending the need of the proceeds thereof for the purpose for which said bonds were authorized; therefore ²

BE ITRESOLVED AND ORDERED BY THE BOARD OF DIRECTORS OF FRANKLIN COUNTY WATER DISTRICT:

<u>SECTION 1 :</u> That bonds numbered 61 through 320 of the above -described series, in the aggregate principal amount of \$1,300,000, shall forthwith be delivered to the purchaser, POSTEL SECURITIES COMPANY, upon payment therefor at the price of 102-1/4 plus accrued interest to the date of delivery.

<u>SECTION 2</u>: That bonds numbered 1 through 60 of the above-described series, in the aggregate principal amount of **\$300,000**, shall be deposited in escrow with The American National Bank of Austin, Austin, Texas, for safekeeping pending the direction of this Board to deliver such bonds to the purchaser.

<u>SECTION 3:</u> That the Secretary of this Board be authorized and he is hereby directed to forward a certified copy of this resolution to the American National Bank of Austin, Texas, as its authority to deliver the bonds described in Section I hereof to said purchaser and as its authority to hold the remainder of the bonds of said series as proveded in Section 2 hereof.
