Minutes of the Meeting Of the Board Of Directors Of The Franklin County Water District Held February 20, 1967

ON THIS 20th day of February, 1967, The Board of Directors of the Franklin County Water District convened in regular session at the regular meeting place thereof at the office of Woodrow Edwards in the Bolger Building at Mount Vernon, Texas, with the following members present:

D. O. ALDRIDGE was absent.

The President of the Board called the meeting to order, declared a quorum present and that the meeting was duly convened and ready to transact business.

The President then announced that the Board would dispense with reading the Minutes and consider the business at hand.

Motion was made by Mr. Horris Morris and duly seconded by Mr. A. J. Laws to adopt the following Resolution and Order by the Board of Directors of Franklin County Water District Calling an Election for the purpose of Electing Directors.

RESOLUTION AND ORDER BY THE BOARD OF DIRECTORS OF FRANKI IN COUNTY WATER DISTRICT CALLING AN ELECTION FOR THE PURPOSE OF ELECTING DIRECTORS

WHEREAS, by virtue of the provisions d Article 8280-341, V.A.T.C.S., it is necessary that an election be held in Franklin County Water District on April 4, 1967 ² for the purpose of electing three Directors for such District to serve until the first Tuesday in April, **1969**, and thereafter until their successors have been declared elected and qualified; therefore,

BE IT RESOLVED AND ORDERED BY THE BOARD OF DIRECTORS OF FRANKI IN COUNTY WATER DISTRICT: Section 1: That an election be held on the 4th day of April, 1967 the same

being the first Tuesday in April, 1967, within said Franklin County Water District, Franklin County, Texas, for the purpose of submitting to the resident qualified electors of said District the following:

THE ELECTION of three Directors for said FRANKI IN COUNTY WATER DISTRICT to serve until the first Tuesday in April, 1969, and thereafter until their successors have been declared elected and qualified.

<u>SECTION 2:</u> That the manner of holding said election shall be governed by the General Laws of the State of Texas, except as otherwise provided by Article 8280-341, V.A.T.C.S., and all resident qualified electors shall be entitled to vote.

<u>SECTION 3:</u> To be eligible for the office of Director a person must be at least twenty-one years of age, reside in and own land in the territorial limits of the District.

SECTION 4: The polling places and Presiding Judges for the aforesaid election shall be respectively as follows:

The Presiding Judge of a SPECIAL CANVASSING BOARD for absentee balloting shall be Earl Finley.

The Presiding Judge serving at each polling place shall appoint one Assistant Judge and at least two (2) Clerks to assist in holding such election.

ABSENTEE VOTING shall be conducted by the County Clerk at his office in the Courthouse at Mount Vernon, Texas, in accordance with the provisions of Chapter 424, Acts of the 58th Legislature, Regular Session, 1963, and said Clerk shall keep his office open between the hours of 8:00 A. M. and 5:00 P. M. (constitution the Clerk's regular working hours) on each day for absentee voting which is not a Saturday, a Sunday, or an official State holiday.

<u>SECTION 5:</u> That the ballots for said election shall be prepared in sufficient number and in conformity with Chapter 6, V.A.T.C.S., Election Code, and that written or printed on such ballots shall appear the following:

<u>SECTION 6</u> The election officials from each polling place shall make due returns of said election in triplicate to the Board of Directors within five (5) days, one to be retained by the Presiding Judge, one to be delivered to the President of the Board of Directors of the District and one to be delivered to the Secretary thereof.

<u>SECTION 7:</u> The Board of Directors shall give notice of the election herein ordered by publishing a true copy thereof, signed by the President and attested by the Secretary, in a newspaper of general circulation published in Franklin County, Texas, once each week for three consecutive weeks, the first publication to appear at least twenty-one (21) days prior to the date of said election and not more than thirty-five (35) days prior thereto.

PASSED, APPROVED AND ADOPTED, this the 20th day of February, 1967.

Newsome, President of the Board of Directors of Franklin County Water District, DO HEREBY CERTIFY that all proceeds received from the sale of \$1,600.000 principal amount of "FRANKI IN COUNTY WATER DISTRICT BONDS, SERIES 1966" (except such amounts as may represent accrued interest) will be deposited under escrow arrangements with the District's depository, The First National Bank of Mount Vernon, Mount Vernon, Texas, which will provide that such Bank will not release such funds for the acquisition and construction of the District's dam and reservoir project for which such bonds were authorized until such Bank has received r)notification from the Executive Directors of both the Texas Water Development Board and the Texas Water Rights Commission authorizing the release of such funds for such purposes.

This certificate is given in consideration of the approval by the Texas Water Rights Commission of the District's project and the issuance of bonds therefor under the provisions of Article 7880-139, R.C.S. of Texas, 1925

as amended, prior to its approval of the final construction plans and specifications, and it is understood that the notifications aforementioned shall be forwarded promptly to the District upon Commission approval of such final construction plans and specifications by the Texas Water Rights Commission and the Texas Water Development Board's concurrence in such Commission approval.
