Mr. Saville attended the meeting and the contract was studied and accepted. The Contract will not be signed until field notes are ready and attached to the contract. Mr. Hicks, the District's engineer, will attend to this matter and the field notes will be ready some time in January.

Mr. Postel's contract was studied by the Board, but due to Mr. Edwards being absent it was again postponed until Mr. Edwards return.

The Directors were paid \$60.00 for attending meetings for 3 months.

A motion was made by Landon Ramsay and duly seconded by D. 0. Aldridge that the monthly bills be paid:

Thereupon the President called for a vote and A!l Members Present voted "Aye". None opposed.
