Mr. Flanagan, the District Land Buyer, recommended to pay Mr. Noel Breedlove's interest so as to obtain a release of lien from Mr. Ruel Mahaffey.

A motion was made by Horris Morris and duly seconded by Landon Ramsay to pay the interest on Mr. Breedlove's property and to buy Mr. Breedlove's land. All Members Present voted "AYE" None Opposed.

Mr. Flanagan gave his appraisal of the following land:

Mr. Flanagan recommended raising the appraisal price on the Spafford land.

Horris Morris moved and A. J. Laws seconded to raise the appraisal price on the Spafford land. All Members Present voted "AYE" None Opposed.

Motion was made by Horris Morris and seconded by D. 0. Aldridge to pay interest on the \$1,300,000.00 bonds out of the Interest and Sinking Fund. All Members Present voted "AYE" None Opposed.

The Board of Directors met with the Commissioners Court to discuss the buying of Highway Right of Way for the Highway that it to be built around the Lake. It was decided to halt this operation for the time being.

After much discussion the Board of Directors made the following Motion.

Motion made by Landon Ramsay and duly seconded by A. J. Laws to advertise for bids on the Franklin County Big Cypress Creek dam and spillway.
