MINUTES OF THE MEETING OF THE FRANKLIN COUNTY WATER DISTRICT HELD: December 15, 1969

ON THIS, the 15th day of December, 1969, the Board of Directros of the Franklin County Water District convened in regular session at the regular meeting place throf in the courthouse at Mount Vernon, Texas, with the followingt members present:

Woodrow Edwards, Attorney for the District, was also present.

The President of the Board called the meeting to order, declared a quorum present and announced that the meeting was duly convened and ready to transact business.

Mr. Edwards discussed the Jacob Solon King, Jr. injunction suit which was heard Friday, December 12, 1969, and stated that the attorneys were given extra time to submit further authorities for the District Judge's consideration and he will render his decision at a later date.

Mr. Edwards also stated that all King cases are set for March 2, 1971; and the Jesse G. Majors suit and the G. D. Gilbert suit are set for January 5, 1970.

A Resolution was submitted to the Board unilaterally terminating and canceling the contract dated January 6, 1969 by and between the Franklin County Water District and Arthur E. Postel dba Postel Securities Company of Austin, Texas. The Resolution having been read in full, it was moved by HORRIS MORRIS, and duly seconded by K. P. LESTER, that the same be passed. Thereupon, the question being called for, and after full discussion and deliberation, all members present voted "AYE". None opposed. The President announced that the motion had carried, and that the Resolution had been adopted. The Resolution is attached to these Minutes and made a part thereof.

Mr. Edwards discussed the Saville-Baker Brick Company, Inc. matter and stated that Walter F. Hicks, Jr., Engineer for the District, had informed the Board that the soil covered by the lease to Saville-Baker Brick Company, Inc. is the type of soil needed for the dam. The paragraph in the lease contract was discussed wherein it states that the District could cancel the lease contract upon the non-payment of advance royalty to District on or before December 2, 1969. Since the advance royalty was not paid to the District on or before that date, a resolution was submitted to theBoard canceling and terminating the Lease-Contract dated January 1, 1969 between Franklin County Water District and Saville-Baker Brick Company, Inc. LANDON RAMSAY moved to accept and adopt the resolution canceling and terminating the lease contract, and the second was duly made by K. P. LESTER. Thereupon, the question being called for, and after full discussion and deliberation, all members present voted "AYE". None opposed. The President announced that the motion had carried and that the Resolution had been adopted. The Resolution is attached to these Minutes and made a part thereof.

The Board members requested Woodrow Edwards to draft a letter to be sent to Saville-Baker Brick Company, Inc. informing them of the Board's decision, including therein the fact that the District would use as much of the \$200.00 forfeit money placed with the District to restore the land to a fair condition, and the remainder of the \$200.00, if any, would be returned to Saville-Baker Brick Company, Inc.

C. G. ROSS et al, 22.268 acres out of 118 acre tract in the J. R. Blair Survey, A-32.

Motion was made by HORRIS MORRIS, and duly seconded by A. L. LAWS, that the appraisals as submitted by Mr. Flanagan be accepted and approved. The question being put by the President, and discussion had thereon, all members present voted "AYE". None opposed.

The President reported that 12.287 acres of land had been purchased from E. E. Evers and wife, Eula Evers and check No. 474 was issued to them December 9, 1969 therefor.

Motion was made by Landon Ramsay, and duly seconded by A. J. Laws, to approve and pay the current bills, and to make payment for anyf eminent domain proceedings that might come due before the next Board Meeting. The question being put by the President, and discussion had thereon, all members present voted ""SAYE". None opposed.
