ON THIS the 6th day of October, 1969, the Board of Directors of the Franklin County Water District met in regular session at the regular meeting place thereof in their office located in the courthouse in Mount Vernon, Texas, with the following present:

Also present were Woodrow Edwards, Attorney for the District; and James T. Bass, Editor of the Mount Vernon Optic-Herald.

The President called the meeting to order, declared a quorum present, and announced the Board was ready to transact business.

Mr. Newsome reported that W. R. Boyd, Inc., Contractors for the lake basin clearance, were 22% completed with the clearance, with only 20.4% time used.

Mr. Edwards discussed the progress of obtaining signatures of the Lovelace heirs on the deed to the Franklin County Water District. He also stated that contact had been made with Mr. H. L. Glaze.

Discussion was had in the matter of the postponement of the J. Solon King temporary injunction suit, which postponement was caused by conflict of another suit by Mr. Sharp, attorney for the Kings.

Mr. Edwards also stated that Mr. Flanagan would have some land appraisals in the next few days to be considered by the Board for approval. The Office Secretary was instructed to call a Special Meeting of the Board when the appraisals reached the office.

Motion was made by HORRIS MORRIS, and duly seconded by LANDON RAMSAY, to raise the salary of Berniece E. Meek to \$343.70 per month, retroactive to August 1, 1969. On the question being put by the President, and after discussion, all members present voted "AYE". None voted "NO".
