ON this, the 15th day of June, 1970, the Board of Directors of the Franklin County Water District convened in regular session at the regular meeting place thereof in the courthouse at Mount Vernon, Texas, with the following members present:

Also present were the following: Messrs. Woodrow Edwards, Attorney for the District; Walter F. Hicks, Jr., Engineer for the District; and Neal Solomon, State Representative.

The President of the Board called the meeting to order, declared a quorum present and that the meeting was duly convened and ready to transact business.

The President then announced that the Board would dispense with the reading of the Minutes and consider the business at hand.

Woodrow Edwards discussed the necessity of retaining and Attorney in Austin to assist in the trail of Civil Action No. A 70 CA 40, United States District Court for Western District of Texas, Austin Division, styled Arthur E. Postel, Individually and d/b/a Postel Securities Company vs. Franklin County Water District et al. Whereupon, a Resolution was submitted authorizing the retaining of Martin Harris, a member of the law firm of Clark, Thomas, Denius & Winters. Said Resolution was passed, adopted and accepted and is attached to these Minutes and made a part hereof.

Mr. Edwards announced that Eminent Domain Proceedings #1014, Cilfford Pynes et al; and Sallie A. McClung et al #1013 would be heard June 15, 1970 and June 25, 1970, respectively.

Mr. Hicks stated that Dan Mize of Bonham, Texas had requested him to report to the Board that he would be interested in meeting with the Board to discuss making application for Manager of Lake Franklin County.

Mr. Hicks also informed the Board that our Water Permit states that the Franklin County Water District will have to set sedimentation ranges. He also stated that ten years after the sedimentation ranges have been set and established, that the soil Conservation people will again take the sedimentation rate. Me. Hicks discussed the needs for concrete markers establishing permanent sedimentation ranges and stated that the cheapest way to set markers is concrete posts or 4 ft. long pipes with a cap on it that denotes the elevation. He also stated that the work of setting the permanent markers and running the ranges should be completed by July or August.

MOTION was made by LANDON RAMSAY, and duly seconded by K. P. LESTER, to pay the bills, and to make payment for any purchase of land that might arise between now and the next Board meeting. After discussion, the President put the question and all members present voted "AYE". None opposed.
