ON this the 6th day of December, 1971, the Board of Directors of the Franklin County Water District convened in regular session at their office located at 114 North Houston Street on the east side of the square in Mt. Vernon, Texas, with the following members present:

Also present were the following: Marion W. Russell, General Manager of the District; Woodrow Edwards, Attorney for the District; Berniece E. Meek, Assistant Manager of the District; M. D. Carlock, Attorney for M4rs. J. P. Munn; and Mrs. J. P. Munn, adjoining landowner.

The President of the Board called the meeting to order, declared a quorum present, and that the meeting was duly convened and ready to transact business.

Notice of this meeting and agenda was given, stating the time and place and purpose of said Meeting, all as required by Vernon's Ann. Civ. St., Article 6252-17.

A RESOLUTION was passed, adopted and approved gratefully acknowledging the gift of coffee mugs by Wood County Electric Co-operative, Inc. The Resolution is attached to these Minutes and made a part thereof.

Mr. Carlock and Mrs. Munn discussed with the Board the fact that an error had been made in surveying and that the King's land had extended south into the Munn's north side of their residue, thereby cutting down the amount of their acreage.

WHEREUPON, MOTION was made by K. P. LESTER, and duly seconded by LANDON RAMSAY, to authorize the General Manager and Woodrow Edwards to work

out an agreement for the District to convey to the Munn's, by lease or deed, acreage on the east side of the Munn's residue, to be the same amount which had been erroneously surveyed on the north side of their residue. The President put the question, and after full discussion and deliberation, all members present voted "AYE". None voted "NO".

Mr. Carlock suggested that a clause be added to the Lease reducing the amount of the rental by the amount of acreage covered by the road. The General Manager recommended to the Board that the clause not be added to the lease.

WHEREUPON, MOTION was made by A. J. LAWS, and duly seconded by LANDON RAMSAY, to accept the recommendation of the General Manager that the clause not be added to the lease reducing the amount of the rental by the amount of acreage covered by the road. The President put the question and, after full discussion and deliberation had thereon, all members present voted "AYE". None voted "NO".

Mr. Carlock stated that, since the clause will not be added to the lease, he requested that the Franklin county Water District reduce the amount of rental to be paid by the Munn's each year.

The General Manager recommended to the Bord that Mr. Carlock's request not be accepted.

WHEREUPON, MOTION was made by LANDON RAMSAY, and duly seconded by A. J. LAWS, to accept the recommendation of the General Manager and that Mr. Carlock's request that the District reduce the amount of rental to be paid by the Munns each year be denied. The President put the question, and after full discussion and deliberation had thereon, the members present voted as follows: AYES: W. C. Newsome, Landon Ramsay, Horris Morris, A. J. Laws. NOES: K. P. Lester. The President announced that the Motion had carried.

Mr. Russell reported on his trip to Austin to meet with the Parks and Wildlife Department in regard to the Boat Ramp Program.

MOTION was made by A. J. LAWS, and duly seconded by HORRIS MORRIS, to renew the Workmen's Compensation Insurance with Mt. Vernon Insurance Company. The President put the question, and after deliberation all members present voted "AYE". None voted "NO".

MOTION was made by LANDON RAMSAY, and duly seconded by A. J. LAWS, to approve and make payment of the bills due and of any salaries that might come due before the next Board Meeting. The President put the question, and after discussion and deliberation, all members present voted "AYE". None voted "NO".
