## MINUTES OF THE MEETING OF THE BOARD OF DIRECTORS OF THE FRANKLIN COUNTY WATER DISTRICT HELD: July 19, 1971

ON THIS the 19<sup>th</sup> day of July, 1971, the Board of Directors of the Franklin County Water District convened in regular session at their regular meeting place thereof located in their office in the Ramsay Building on West Main Street, Mount Vernon, Texas, with the following members present:

and with the following absent: NONE.

Also present were Woodrow Edwards, Attorney for the District; Berniece E. Meek, Assistant Manager; G. D. Gilbert, landowner; Robert W. Caldwell and Roger A. Powell, Jr. Planning Consultant with the firm of Robert W. Caldwell & Associates.

The President called the meeting to order, declared a quorum present, and that the meeting was duly convened and ready to transact business.

The President stated that, complying with the law, notice of this meeting and the agenda had been filed with the County Clerk of Franklin County, Texas and posted by said Clerk on the Bulletin Board at the Court House, and posted by the Franklin County Water District on their Bulletin Board in their office at least three days prior to July 19<sup>th</sup>, 1971.

The President announced that the reading of the Minutes would be dispensed with and the Board would consider the business at hand.

Mr. Gilbert requested permission to lease back some of the land the District had previously purchased from him, and also the permission to cut a channel from the lake to a slough on his land. Mr. Edwards stated that there was an Agreed Judgement in which Mr. Gilbert was allowed to retain all land above the 390 normal water level and that the District retained a roadway just on top of the 390.

Mr. Gilbert was informed by the Board that we are in no position to lease any land at the present time because we have made an agreement with the Texas Water Development Board to cease all leasing until we have an overall comprehensive plan made of the lake. He was also informed that the same agreement would apply to the cutting of the channel.

Mr. Caldwell, with the assistance of Mr. Powell, outlined a comprehensive plan for the lake and lake area which will include Use Area Designations, recreational use, residential uses,

commercial uses, industrial uses, public lease area, circulation and access systems by roads, and methods of implementation of the land use such as how to go about getting road systems developed, public use areas developed, and will also have detail plans for individual park sites such as boat ramp, picnic areas and camp sites.

Mr. Caldwell stated that due to the fact that much of the basic work had been done and paid for by the District, their services will be for the total price of \$9,750.00, they are in a position to begin immediately and can finish the project within a 90 days period.

MOTION was made by LANDON RAMSAY, and duly seconded by A. J. LAWS, to employ the firm of Robert W. Caldwell & Associates, Planning Consultants, to make a comprehensive plan for Franklin County Water District, and that the President and Secretary be authorized to enter into a contract with said firm. The President put the question, and after full discussion and deliberation had thereon, all members present voted "AYE". None voted "NO". The President announced that the Motion had carried. A copy of the Resolution is attached hereto and made a part of these Minutes.

K. P. Lester was authorized by the Board of Directors to have the grass on the dam irrigated by the following action: MOTION was made by LANDON RAMSAY, and duly seconded by HORRIS MORRIS, that K. P. Lester be authorized to see that the grass on the dam was irrigated. The President put the question, and after discussion, all members present voted "AYE". None voted "NO".
