On this 20th day of September, 1971, the Board of Directors of the Franklin County Water District convened in a regular session at their office located in the District's office Building on the east side of the Square in Mt. Vernon, Texas, with the following members present:

Also present were the following: Marion W. Russell, General Manager of the District; Woodrow Edwards, Attorney for the District; Robert W. Caldwell and Roger A. Powell, Jr., Planning Consultants; Earl Sharp, Attorney from Longview, Texas representing J. S. King et al; J. Solon King and Tom King.

The President of the Board called the meeting to order, declared a quorum present, and that the meeting was duly convened and ready to transact business.

Notice of this meeting and the agenda had been filed with the County Clerk of Franklin County, Texas, posted by said Clerk on the Bulletin Board at the Courthouse, and posted by the Franklin County Water District on their Bulletin Board in their office at lease three days prior to this meeting date, to-wit: September 20, 1971.

Messrs. Caldwell and Powell presented a preliminary sketch of the overall land use plan for the lake property, including a circulation system, and maps showing existing and proposed lease- back sites. A full discussion was had on this matter.

A general discussion was had with Mr. Sharp and the Kings regarding the District acquiring rights of way for access roads from the Kings would be allowed to clear an inlet which had not been cleared by the clearing contractor, and further would be allowed to lease certain acreage adjoining the inlet, in exchange for access

roads on the north and south sides of the lake, however, said leasing would be subject to the approval of the Texas Water Development Board. The General Manager of the District, together with the Attorney and Board Members and the Planning Consultants made plans to meet with staff of TWDB in Austin to discuss and secure approval of the leasing of this acreage to the Kings.

MOTION was made by LANDON RAMSAY, and duly seconded by HORRIS MORRIS, to pay the bills, which will include salaries that will be due before the next Board meeting, also the Directors Fees and any expenses incurred in attending the business of the District. The President put the question, and after discussion, all members present voted "AYE". None voted "NO".
