ON THIS the 21st day of August, 1972, at 1:30 P.M., the Board of Directors of the Franklin County Water District convened in regular session at their office located at 114 North Houston Street on the North side of the square in Mount Vernon, Texas with the following members and officers present:

Also present were Marion W. Russell, General Manager; Horris Morris, Lake Superintendent, Milton Kelly, Developer of Snug Harbor, and Edward L. Lyman.

The Secretary, presiding in the absence of the President and Vice President, called the meeting to order, declared a quorum present, and that the meeting was duly convened and ready to transact business.

NOTICE of this meeting was given, stating the time, place and purpose, all as required by Vernon's Ann. Civ. St., Article 6252-17.

MOTION was made by BILLY M. JORDAN, and duly seconded by ENNIS D. CHRISTENBERRY, to approve

2 I/2 acre 10% leaseback of NELL F. STRINGFELLOW, and authorize the President and Secretary to execute same on

behalf of the Franklin County Water District. The Presiding Officer put the question, and after full discussion had thereon,

all members present voted "AYE". NONE voted "NO".

Mr. Morris gave a general report regarding the park site on the south side of the lake and discussed proposed plans

for a temporary boat ramp at that location. The Board authorized Woodrow Edwards to contact Dr. Hubert Johnson of

the Methodist Home Foundation for the purpose of obtaining a right-of-way of approximately 5 acres for proposed park. A

lengthy discussion was had in this matter but no action was taken.

Mr. Lyman met with the Board for the purpose of obtaining permission to move a barge-type float on the Water

District property for the purpose of painting it and then later to ask permission to float it on the lake.

JORDAN, to approve and make payment of the bills and of any salaries, withholding taxes and social security payments that might come due before the next Board Meeting; and to close out the Recreation & Lease Fund and Reservoir Construction Fund by transferring the remaining funds on hand in the bank to the Maintenance & Operating Fund.
