ON THIS the 7th day of February, 1972, the Board of Directors of the Franklin County Water District convened in regular session at their office located at 114 North Houston Street in Mount Vernon, Texas, with the following members present:

Also present were the following: Marion W. Russell, General Manager of the District; Woodrow Edwards, Attorney for the District; and Berniece E. Meek, Assistant Manager and Secretary of the District.

The President of the Board called the meeting to order, declared a quorum present, and that the meeting was duly convened and ready to transact business.

NOTICE of this meeting and agenda was given, stating the time, place and purpose, all as required by Vernon's Ann. Civ. St., Article 6252-17.

MINUTES of December 6 and December 20, 1971 were read and approved.

The President submitted to the Board a Resolution calling an election for the purpose of electing two Directors. The Resolution and Notice of election are attached to these minutes and made a part thereof.

A RESOLUTION was presented to the Board by President Newsome approving the Lease Agreements as written, being a lease of land on which to construct a residence and a Marina, Fishing Lodge and Related Facilities Lease, and being negotiated by F. A. Daugherty with Franklin County Water District. The said Resolution was passed, approved and adopted and is attached to these Minutes and made a part thereof. Copies of the LEASE AGREEMENT and the MARINA, FISHING

LODGE, and RELATED FACILITIES LFASE will be attached to these Minutes and made a part thereof, if and when they are executed.

Marion W. Russell discussed with the Board the 10% leaseback of W. D. Guthrie and his wife, Velma Guthrie; Joe Dan Guthrie and his wife Rhonda Guthrie; Melanie Ann Carpenter and her husband, Tommy Lynn Carpenter, and submitted the location of the said 10% to the Board for their approval or disapproval. Whereupon, MOTION was made by K. P. LESTER, and duly seconded by A. J. LAWS, for Marion W. Russell to proceed with the 10% leaseback to W. D. Guthrie and his wife, Velma Guthrie; Joe Dan Guthrie and his wife Rhonda Guthrie; and Melanie Ann Carpenter and her husband, Tommy Lynn Carpenter, and request that they furnish proper field notes to the Water District. The President put the question, and after full discussion had thereon, all members present voted "AYE". NONE voted "NO".

MOTION was made by BILLY M. JORDAN, and duly seconded by LANDON RAMSAY, to ratify and confirm the LEASE AGREEMENT executed by the District on the 20th day of November, 1971, to Earl Sharp and Tom King, in exchange for a right-of-way easement. (A copy of the LEASE AGREEMENT and a copy of the Deed from the Kings to the District for Right-of-Way purposes are attached to the Minutes of November 15, 1971, and made a part thereof.) The President put the question, and after full discussion had thereon, all members present voted "AYE". NONE voted "NO".

MOTION was made by LANDON RAMSAY, and duly seconded by K. P. LESTER, to submit a statement for 16 days sale of water to the City of Mount Pleasant. The President put the question, and after full discussion had thereon, all members present voted "AYE". None voted "NO".

MOTION was made by LANDON RAMSAY, and duly seconded by BILLY M. JORDAN, to approve and make payment of the bills which will include all salaries that might come due before the next Board Meeting, also the payment to Mercantile National Bank at Dallas for coupons due. The President put the question, and after full discussion, all members present voted "AYE". NONE voted "NO". The bills and disbursements are as follows:
