ON THIS the 5th day of June, 1972, at 1:30 P. M., the Board of Directors of the Franklin County Water District convened in regular session at their office located at 114 North Houston Street on the east side of the square in Mount Vernon, Texas, with the following officers and members present:

Also present were Woodrow Edwards, Attorney for the District; Marion W. Russell, Manager; Horris Morris, Lake Superintendent; L. J. Flanagan, Real Estate Broker of Palestine, Texas; Thomas D. Ramsay, Neal Holm and Olen Ratliff.

The President of the Board called the meeting to order, declared a quorum present, and that the meeting was duly convened and ready to transact business.

NOTICE of this meeting and agenda was given, stating the time, place and purpose, all as required by Vernon's Ann. Civ. St., Article 6252-17.

The staff reported that David Pollard, Surveyor, had mailed the field notes to the office for Joe Dan Guthrie's 10% leaseback, whereupon the following actin was taken: MOTION was made by BILLY M. JORDAN, and duly seconded by A. J. LAWS, that JOE DAN GUTHRIE'S 10% leaseback of 7 ½ acres be approved, and that the President and Secretary be authorized to execute said Lease Agreement on behalf of the District. The President put the question and, after full discussion had thereon, all members present voted "AYE". NONE voted "NO".

MOTION was made by ENNIS D. CHRISTENBERRY, and duly seconded by A. J. LAWS, to have a new communication radio installed in the Lake Superintendent's pickup which will keep him in contact with the Sheriff's Department and the Game Warden with the Texas Parks and Wildlife Department. The President put the question and, after due consideration had thereon, all members present voted "AYE". NONE voted "NO".

MOTION was made by A. J. LAWS, and duly seconded by BILLY M. JORDAN, to authorize Horris Morris to make improvements to the beach and park areas, such as sand, floats and picnic tables. The President put the question and, after discussion, all members present voted "AYE". NONE voted "NO:"

Mr. L. J. Flanagan, Real Estate Broker for the District, made his recommendation to the Board as to the prices to be placed on the land which is to be leased, whereupon, MOTION was made by BILLY M. JORDAN, and duly seconded by A. J. LAWS, to accept and approve the appraisals as made by L. J. Flanagan and to offer the land for lease as set out in the appraisal. The President put the question and, after full discussion, all members present voted "AYE". NONE voted "NO".

MOTION was made by ENNIS D. CHRISTENBERRY, and duly seconded by BILLY M. JORDAN, to rezone the area of approximately 50 acres, more or less, just north of what has been called the "35 acre park" (which 50 acres are shown as 4-A on Mr. Flanagan's appraisal map) from "PARK AREA" to "SINGLE RESIDENTIAL AREA" and rezone the lower pennisula just below Snug Harbor Development from "SINGLE RESIDENTIAL AREA" to "PARK AREA", it being a swap of like kind; and further to approve Mr. Flanagan's appraisal of \$1,750.00 per acre on said No. 4-A of said 50 acres, more or less; and further, to authorize the President and Secretary to execute a Contract to Lease Land to Ross J. Love, Jr., Trustee, on behalf of the Franklin County Water District, for approximately 100 acres of land, more or less. The President put the question and, after full discussion had thereon, all members present voted "AYE". None voted "NO". A copy of the Contract to Lease Land will be attached to these Minutes and made a part thereof when executed.

MOTION was made by BILLY M. JORDAN, and duly seconded by A. J. LAWS, to extend the bid opening date for the construction of the boat ramp on Lake Cypress Springs from May 26, 1972, 9 o'clock a. m. to June 26, 1972, 9 o'clock a.m. due to the fact there were no bids submitted. The President put the question and, after due consideration had thereon, all members present "AYE". NONE voted "NO".

MOTION was made by BILLY M. JORDAN, and duly seconded by A. J. LAWS, to approve and make payment of the bills now due and of any salaries that might come due before the next Board Meeting. The President put the question and, after due consideration had thereon, all members present voted "AYE". NONE voted "NO". The bills are as follows:
