MINUTES OF THE MEETING OF THE BOARD OF DIRECTORS OF THE FRANKLIN COUNTY WATER DISTRICT HELD: March 6, 1972

ON THIS the 6th day of March, 1972, the Board of Directors of the Franklin County Water District convened in regular session at their office located at 114 North Houston Street in Mount Vernon, Texas, with the following members present:

Also present were the following: Marion W. Russell, General Manager of the District; Woodrow Edwards, Attorney for the District, Berniece E. Meek, Assistant Manager of the District; Verne Erion and Milton R. Kelley.

The President of the Board called the meeting to order, declared a quorum present, and that the meeting was duly convened and ready to transact business.

NOTICE of this meeting and agenda was given, stating the time, place and purpose, all as required by Vernon's Ann. Civ. St., Article 6252-17.

Mr. Erion met with the Board on behalf of the Veterans of Foreign Wars and requested 4 or 5 acres on which to build a meeting place which would cost approximately \$70,000.00. The Board instructed him to meet with the Manager and to make a selection of a building site on the lake and then report to the Board for their approval or disapproval.

Milton Kelley presented a letter to the Board requesting a waiver on all lots in Phase I, II and III as to their size. He stated that the lots were surveyed, platted and filed prior to the effective date of the District's rules and regulations stating that all lots must be one-half acre in area and at least 100 feet in width. He also requested that the Board approve a variance to the zoning rule to exclude lots 53, 54, 55, 56, 57, 58, 59, 63, 62, 61, 60, 116 and 117 stating that these lots are in an area or block previously designated as mobile home area prior to the effective date of the zoning rule, and that these lots are contiguous to an area of fee property also a part of the mobile home area. A copy of the letter is attached to these minutes and made a part thereof.

Whereupon, MOTION was made by LANDON RAMSAY, and duly seconded by BILLY M. JORDAN, to approve a waiver on all lots in Phase I, II and III in Snug Harbor Development as to their size due to the fact that they were surveyed, platted and filed prior to the effective date of the District's rules and regulations, and also to approve a variance to the District's zoning rule to exclude lots 53, 54, 55, 56, 57, 58, 59, 63, 62, 61, 60, 116, and 117 which are in the area or block previously designated as mobil home area prior to the effective date of the District's zoning rule; and further that the President of

the Franklin County Water District be authorized to sign the letter of waiver requested be Milton Kelley on behalf of the District. The President put the question, and after full discussion and deliberation had thereon, all members present voted "AYE". NONE voted "NO".

MOTION was made by LANDON RAMSAY, and duly seconded by BILLY M. JORDAN, to approve and make payment of the bills now due, and of any salaries that might come due before the next Board Meeting. The President put the question, and after full discussion and deliberation had thereon, all members present voted "AYE". NONE voted "NO". The bills are as follows:
