# MINUTES OF THE MEETING OF THE BOARD OF DIRECTORS OF THE FRANKLIN COUNTY WATER DISTRICT

ON THIS the 16th day of October, 1972, at 1:30 P.M., the Board of Directors of the Franklin County Water District convened in regular session at their office located at 114 North Houston Street on the east side of the square in Mount Vernon, Texas, with the following officers and members present:

Also present were the following: Marion W. Russell, Manager; Horris Morris, Lake Superintendent; Woodrow Edwards, Attorney; L. J. Flanagan, Real Estate Broker; John P. Travis, III of Dallas, Texas; and Tom D. Ramsay, representing Tall Tree Development.

The President of the Board called the meeting to order, declared a quorum present, and that the meeting was duly convened and ready to transact business.

NOTICE of this meeting was given, stating the time, place and purpose, all as required by Vernon's Ann. Civ. St., Article 6252-17.

Mr. Flanagan introduced Mr. Travis, who is interested in leasing acreage from the District for development purposes. Mr. Travis stated that he had been shown the acreage on the south side of the lake by Mr. Flanagan, which tracts are designated on Mr. Flanagan map as Tracts 18, 18A and 19. Mr. Travis presented and discussed some provisions relative to the said tracts, the Board acknowledged the provisions and agreed that, with some changes in the usual lease provision, they are to become a part of a future lease to be entered into by the parties. No further action was taken at this time.

Tom D. Ramsay, representing TALL TREE Development, appeared before the Board to make a request of the District for the payment of a portion of the cost of Tall Tree title policy. The Board stated that it is not the policy of the District to furnish the cost of title policies, whereupon, Mr. Ramsay retired from the meeting.

Mr. Edwards reported that the Directors' deposition would be taken October 27, 1972, at 10 a. m. in the District Court Room, Franklin County, Texas in regard to the Lowell T. Miller lawsuit.

MOTION was made by A. J. LAWS, and duly by ENNIS D. CHRISTENBERRY to approve the W. B. Swanner and H. D. Swanner leaseback, and to authorize the president and Secretary to execute same when prepared on behalf on the Franklin County Water District. The President put the question and, after full discussion had thereon, all members present voted "AYE". NONE voted "NO". A copy of the LEASE AGREEMENT will be attached to these Minutes and made part thereof when executed.

MOTION was made by A. J. LAWS, and duly seconded by K. P. LESTER, to approve an easement and right-of-way 10 feet in width and approximately 104 feet in length over and across a part of the Nannie Cates tract of land in the J. E. Hopkins A-217 survey to Southwestern Electric Power Company, and authorized the President and Secretary to execute same on behalf on the Franklin County Water District. The President put the question and, after full discussion had thereon, all members present voted "AYE". NONE voted "NO". A copy of said easement is attached hereto and made a part of these Minutes.

The Minutes of October 2, 1972 were read and approved.

MOTION was made by K. P. LESTER, and duly seconded by A. J. LAWS, to approve and make payment of the bills and of any salaries, withholding and Social Security taxes that might become due before the next Board meeting.
