ON THIS the 18th day of September, 1972, at 1:30 P.M., the Board of Directors of the Franklin County Water District convened in regular session at their office located at 114 North Houston Street on the east side of the square in Mount Vernon, Texas, with the following officers and members present:

Also present were the following: Horris Morris, Lake Superintendent; Woodrow Edwards, Attorney for the District; Milton Kelley, Developer; and L. J. Flanagan, Real Estate Broker for the District.

The President of the Board called the meeting to order, declared a quorum present, and that the meeting was duly convened and ready to transact business.

NOTICE of this meeting was given, stating the time, place and purpose, all as required by Vernon's Ann. Civ. St., Article 6252-17.

MOTION was made by A. J. LAWS, and duly seconded by BILLY M. JORDAN to approve the

Lease Agreements to Ross J. Love, Jr., Trustee, one being for 70.145 acres and the other for 164.856 acres of land, and authorize the President and Secretary to execute same on behalf of the Franklin County

Water District. The President put the question and, after full consideration had thereon, all members present voted "AYE". None voted "NO". A copy of each Lease Agreement will be attached to these Minutes and made a part thereof when executed.

Milton Kelley met with the Board requesting a water line easement on District land. He stated that, if he could secure the easement to the area

that has been set aside for the resident taxpayers on the north side of the lake, treated water could be made available by Snug Harbor Water Supply Company to the potential lot owners desiring same. Whereupon, the following action was taken: MOTION was made by ENNIS D. CHRISTENBERRY,

and duly seconded by A. J. LAW, to approve a Water Line Easement and Sales Agreement to Snug Harbor Water Supply Co., and authorize the President and Secretary to execute same on behalf of the Franklin County Water District. The President voted "AYE". NONE voted "NO". A copy of the Water

Line Easement and Sales Agreement is attached to these Minutes and made a part thereof.

HORRIS MORRIS reported to the Board that he had investigated all places on each side of the lake that might be suitable for the construction of a permanent boat ramp and found that, in his opinion, the place west of the dam would be the best selection. The Board unanimously agreed with Mr. Morris' selection.

Mr. Morris reported that three persons in King's County have built boat docks below 378 MSL elevation. The Board recommended that Mr. Morris instruct them to move their boat docks back on the 378 MSL elevation.

MOTION was made by A. J. LAWS, and duly seconded by ENNIS D. CHRISTENBERRY, that Mr. Morris inform the persons who have placed posts lower that 378 MSL elevation to have them taken up; and to also inform the persons who have the two houses built over the water in King's Country

to remove them or pay the 15¢ per square foot annually. The President put the question and, after full discussion had thereon, the vote was as follows: "AYE": Landon Ramsay, A. J. Laws, Billy M. Jordan and Ennis D. Christenberry. "NO". None. K. P. Lester abstained.

MOTION was made by ENNIS D. CHRISTENBERRY, and duly seconded by BILLY M. JORDAN, to approve and make payment of the bills and of any salaries, taxes, that might become due before the next board meeting. The President put the question and, after full discussion had thereon, the

vote was as follows: "AYES". None voted "NO".
