ON THIS the 3rd day of December 1973, the Board of Directors of the Franklin County Water District convened in regular session at their office located at 114 North Houston Street in the East side of the square in Mount Vernon, Texas, with the following members and officers present:

The President called the meeting to order, declared a quorum present and the meeting was duly convened and ready to transact business.

NOTICE of this meeting was given, stating the time, place and purpose, all as required by Vernon's Ann. Civ. Statutes, Article 6252-17.

MOTION was made by BILLY JORDAN, and duly SECONDED by A. J. LAWS, to make payment of bills, with two exceptions (check #1608 and #1618), subject to approval by Horris Morris, and any salaries, withholding and social security taxes which may come due before the next Board meeting. The President put the question and, after full discussion and deliberation had thereon, all present voted "AYE". NONE voted "NO".

MOTION was made by A. J. LAWS, and duly SECONDED by BILLY M. JORDAN, that the President of the Board be authorized to issue a Resolution to pay Texas Water Development Board \$27,099.02, their share, upon our receiving payment from Industrial Generator. The President put the question and, after full discussion and deliberation had thereon, the following voted "AYE": A. J. LAWS, BILLY M, JORDAN, and LANDON RAMSAY. The following voted "NO": NONE. K. P. LESTER and ENNIS D. CHRISTENBERRY were absent. Said Resolution is attached hereto and made a part of these Minutes, when executed.

Horris Morris, Lake Superintendent, discussed his trip to Austin to meet with Lutcher Simmons, Attorney for Texas Water Development Board. It was learned that since the water must be controlled from the 378' mean

sea level to the 390' MSL on District property and such control is not possible on fee land, a land trade was not feasible with King's Country. District could either lease or buy the

necessary acreage in order to complete a pending transaction with another developer. It was suggested Mr. Morris contact Bill Cullen.

A lengthy discussion followed about (1) the original decision of "take-land" procedure; (2) needed repair on back side of dam and (3) the hiring of an auditor. No action was taken.

MOTION was made by BILLY M. JORDAN, and duly SECONDED by A. J. LAWS, to authorize the President and Secretary to execute a Partial Release of Lien on Lot #4 and #8 for Swannerland, Inc. The President put the question and, after full discussion had thereon, all present voted "AYE". NONE voted "NO". A copy of said Partial Release of Vendor's lien will be attached to these Minutes and made a part thereof, when executed.

Minutes were read and approved for September 17, 1973, October 1, 1973, and October 15, 1973.

There being no further business, the meeting was adjourned.
