The President of the Board called the meeting to order, declared a quorum present, and that the meeting was duly convened and ready to transact business.

NOTICE of this meeting and agenda was given, stating the time, place, and purpose, all as required by Vernon's Ann. Civ. St., Article 6252-17.

MOTION was made by ENNIS D. CHRISTENBERRY, and duly SECONDED by A. J. Laws, to approve plats of King's Country as presented by Bill Cullen. The President put the question, and after full discussion had thereon, all members present voted "AYE." NONE voted "NO."

The Board requested that the office be kept open from 9 A. M. until 5 P. M. on weekdays and from 9 A. M. until 12: 00 noon on Saturdays.

Woodrow Edwards presented a letter which had been dictated over the telephone to Jean Slaughter by Mrs. S. A. Nordstrom. Mrs. Nordstrom would like to have a buoy placed in the cove near her home. Buoys for this purpose have not been approved or been deemed necessary by the Board; therefore no action was taken.

Mr. Edwards reminded the Board of the petition for tax exemption on trade offered by the District.

Robert Byrd had inquired about placing a mobile home on lots 103 and 104 in Snug Harbor. The Board agreed that since a mobile home is now on the lot, Mr. Byrd would be allowed to place another one on these lots if he does purchase said lots.
