MINUTES OF THE MEETING OF THE BOARD OF DIRECTORS OF THE FRANKLIN COUNTY WATER DISTRICT HELD: April 1, 1974

ON THIS the 1ST day of April 1974, the Board of Directors of the Franklin County Water District convened in regular session at their office located at 114 North Houston Street on the East side of the square in Mount Vernon, Texas, with the following present:

Also present were: Woodrow Edwards, Attorney; Horris Morris, Lake Superintendent; Shirley Lykins, Office Manager; Jean Slaughter, Secretary; and Carlton Newsome., President North Franklin Water Supply Corporation.

The President of the Board called the meeting to order, declared a quorum present, and that the meeting was duly convened and ready to transact business.

NOTICE of this meeting was given, stating the time, place, and purpose, all as required by Vernon's Ann. Civ. Statutes, Article 6252-17.

There followed a discussion by Woodrow Edwards, of the Quitclaim and General Easement to H. P. Munn from the District, as well as a Quitclaim and Flood Easement from H. P. Munn to the District, whereupon the following action took place:

The Board approved a Resolution granting a Quitclaim and a General Easement to H. P. Munn. Said Resolution is attached to these Minutes and made a part thereof.

The Board approved the Conditions of the Sale of Lots for the Taxpayer's Additions, East Park and South Park. Said Conditions are attached to these Minutes and made a part thereof. In further action, the Board approved the Restrictions to apply to all lots for both East and South Park Additions. Said Restrictions are

attached to these Minutes and made a part thereof. The Board authorized Horris Morris to put ads in Winnsboro and Mt. Vernon newspapers for two weeks concerning the sale of the lease lots, those dates

being April 13, 1974 and April 20, 1974. In case of rain, then May 4, 1974. The Board further authorized Mr. Morris to hire an auctioneer and together decided the necessary fees for said auction.

Carlton Newsome met with the Board to discuss the still current problems of North Franklin Water Supply Corporation. The Board assured Mr. Newsome they would do what they could to help the group.

The Board adopted a Resolution entering into a contract with Texas Water Development Board concerning the Water Resources Investigation Program. Said Resolution is attached to these Minutes and made a part thereof.

Woodrow Edwards discussed the Postel Case which is upcoming in Austin, April 25, 1974.

Mr. Lester retired from the meeting at this time.

Lake Superintendent Horris Morris discussed repair on the back side of the Dam, some of which will be done by Exco, Inc. of Cooper.

Mr. Morris further discussed the following items of importance: (1) The complaint received by the State Health Department concerning sewage disposal at El Dorado Bay, to which an inspection of the Department reports he could find nothing wrong with the system; (2) The warehouse should be completed this week, then fence will be installed as soon as possible; (3) Further information concerning the trailer hook-ups in Walleye Park; (4) Waterlines to East Park Addition and possibility of underground electric lines; (5) Tall Tree requests the District to inspect their sewage system, to which Mr. Morris suggested fees for such inspection should be increased. An example of charges for sight inspection should be \$5.00, while percolation tests should be changed from \$15.00 to \$25.00. No action was taken on these latter suggestions.

The Board approved the reading of Minutes for January 21, 1974.

MOTION was made by ENNIS CHRISTENBERRY, and duly SECONDED by A. J. LAWS, to approve and make payment of bills, including election costs, and any salaries, withholding and social security taxes, that might come due before the next Board meeting. The President put the question and, after full discussion and deliberation had thereon, all present voted "AYE". NONE voted "NO".
