ON THIS the 5th day of August 1974, the Board of Directors of the Franklin County Water District convened in regular session at their office located at 114 North Houston Street on the East side of the square in Mount Vernon, Texas, with the following present:

Also present were: Horris Morris, Lake Superintendent; Woodrow Edwards, Attorney; L. J. Flananga; Real Estate Broker; Edison Ball, Jr., Snug Harbor Lot Owner; Connie Morris, Student Employee; and Jean Slaughter, Secretary.

The President of the Board called the meeting to order, declared a quorum present, and that the meeting was duly convened and ready to transact business.

NOTICE of this meeting was given, stating the time, place, and purpose, all as required by Vernon's Ann. Civ. Statutes, Article 6252-17.

The President of the Board turned the floor over to K. P. LESTER who discussed all of the ramifications of the North Franklin Water Supply Corporation waterline. Mr. Lester stated the waterline is now 90% complete. He further extended his compliments to the people on whose property the line has gone. The Contractor has received cooperation of all those involved. Mr. Lester recommends partial payment to the Contractor at this time, whereupon the following action was taken:

MOTION was made by K. P. LESTER, and duly SECONDED by BILLY JORDAN, to give the office staff the authorization to pay 75% of the Contractor's bill, when presented, on North Franklin Water Supply Corporation waterline. The President put the question

and, after full discussion and deliberation had thereon, all present voted "AYE". NONE voted "NO".

Edison Ball, Jr. met with the Board requesting the lifting of restrictions for mobile homes on certain lots in Snug Harbor. Following a lengthy discussion, the Board authorized lifting said restrictions on above mentioned lots provided this agreeable with the Developer, after which Mr. Ball retired from the Meeting.

MOTION was made by ENNIS CHRISTENBERRY, and duly SECONDED by BILLY JORDAN, to cancel Snug Harbor Water Purchase contract at the request of Milton R. Kelley, due to the fact that said system is now tied onto the lines of South Franklin Water Supply Corporation. The President put the question and, after which discussion and deliberation had thereon, all present voted "AYE." NONE voted "NO".

L. J. Flanagan discussed the proposed sale of the 16.135 acre tract to Frank Yocom at \$1250.00 per acre. Mr. Flanagan also reported Chester Reed's concern over the abandonment of the county road in the area of land in which the latter is interested.

Woodrow Edwards discussed pending litigations, and further discussed the Texas Water Safety Act.

Horris Morris reported on the following: (1) Various requests of placing oversized boats on the Lake; (2) Work completed behind the dam; (3) Dogwood Park Boat Ramp completion; (4) seemingly wasted hours of labor; and (5) Shower stalls not in use in Walleye Park.

MOTION was made by ENNIS CHRISTENBERRY and duly SECONDED by BILLY JORDAN, to purchase Carl Newsome a plaque commemorating his terms as President of the District. The President put the question and, after full discussion and deliberation had thereon all present voted "AYE". NONE voted "NO."

MOTION was made by ENNIS CHRISTENBERRY, and duly SECONDED by BILLY JORDAN, to approve and make payment of the bills, including Reynaldo Salas & Associates future final bill, but with the exception of check #2049, and any salaries, withholding and social security taxes which might come due before the next Board Meeting. The President put the question and, after full discussion and deliberation was had thereon, all present voted "AYE." NONE voted "NO".
