The President of the Board called the Meeting to order, declared a quorum present, and that the Meeting was duly convened and ready to transact business.

NOTICE of this Meeting was given, stating the time, place, and purpose, all as required by Vernon's Ann. Civ. Statutes, Article 6252-17.

A Resolution was passed, approved and adopted setting the 1976 tax rate and appointing the Mount Vernon Independent School District as agent to make assessments and collections thereof. The Resolution is attached hereto and made a part hereof.

MOTION was made by E. L. SEAY, and duly SECONDED by JEARL COOPER, to ratify payments made since last Board Meeting; and to approve payment of the bills presented; and further, any bills and salaries which might come due before the next Board Meeting.
