## MINUTES OF THE MEETING OF THE BOARD OF DIRECTORS OF THE FRANKLIN COUNTY WATER DISTRICT HELD: July 7, 1976

ON THIS the 7th day of July 1976, the Board of Directors of the Franklin County Water District convened in regular session at their office at 114 North Houston Street on the East side of the square in Mount Vernon, Texas with the following present:

The President of the Board called the Meeting to order, declared a quorum present, and that the Meeting was duly convened and ready to transact business.

The Minutes of June 21, 1976 were read and approved.

MOTION was made by BILLY JORDAN, and duly SECONDED by E. L. SEAY, to ratify the action of the President and Secretary in executing a Release of Vendor's Lien on Lot 7 in East Park to Pat Lindley. The President put the question and, after full discussion had thereon, all present voted "AYE." NONE voted "NO." A copy of said release is attached hereto and made a part hereof.

MOTION was made by JEARL COOPER, and duly SECONDED by E. L. SEAY, to ratify the action taken by the President and Secretary in executing a Partial Release of Vendor's Lien on Lot 10 in Hickory Hill to John Wilhite. MOTION was made by JEARL COOPER, and duly SECONDED by E. L. SEAY, to approve a new distribution line for Wood County Electric Co-Op, Inc. Said line will cross the dam and be placed in the highway right-of-way, having been approved the Texas Highway Department. Discussion was led by L. J. Flanagan concerning acreage east of Grant Harris that the Dahlgrens are interested in leasing. The Board authorized Horris Morris to work with the Dahlgrens on the matter.

Woodrow Edwards discussed matters concerning the El Dorado subdivisions and John P. Travis III.

Horris Morris reported on (1) Correspondence from Texas Water Rights Commission pertaining primarily to erosion on the back side of the dam; (2) Activities during July 4th weekend; and (3) Snug Harbor residents concern over roads and camping in and around residential areas of the development.

The Board authorized work on the dam.

Mr. Cooper retired from the Meeting.

Shirley Lykins discussed (1) John P. Travis and the El Dorado Subdivision; (2) State statutes concerning the District's having tax monies in reserve for a year's payment; (3) Service policies for the office machines; (4) Bond payment due in July before the next Board Meeting; (5) Comparative statement on the Budget; (6) Capital Outlay Expenditure budget; (7) Delinquent accounts; (8) Cash in bank as of June 30, 1976; and (9) Matters concerning Ross J. Love, Jr. and proposed Amendment to Lease.

The Board authorized a service policy for each typewriter.

The Board authorized payment of coupons due to Mercantile National Bank of Dallas upon receipt of statement.

MOTION was made by E. L. Seay, and duly SECONDED by BILLY JORDAN, to amend the Budget to reflect that the Board authorized to spend the following monies for Capital Outlay Expenditures:

The Board approved the staff working with Ross J. Love, Jr. on the amendment to lease as follows:

(2) Bonus payment of \$200.00 per lot for the second 99 year term; and

(3) Rental payment of \$100.00 per lot per annum for the second 99 year term.
