The Board further agreed that Jim Flanagan should be allowed to fulfill the terms of the contract between the District and Mr. L. J. Flanagan, deceased.

Shirley Lykins further reported on the following:

- 1. Possible need of water by the City of Winnsboro;
- 2. South Franklin Water Supply Corporation's upcoming negotiation period;
- 3. An interest expressed by Mr. Tom Beyers in leasing 26.418 acres of land; and
- 4. Request from Mr. Bryant for the Board to reconsider and allow him to lease property adjacent to the northwest corner of his property.

Whereupon the Board instructed the Office Manager to contact Mr. Bryant and advise him that if he did not lease the entire acreage adjacent to him on the north, he must take the lease acreage from the northeast corner of his property.
