She further reported that Mr. T. L. Sanderson objected to paying a permit fee on his boathouse. Mr. Sanderson cannot get his boat into the water. The Board has no control over the rainfall and felt that the fee is just since Mr. Sanderson does have the boathouse out past the 378 elevation.

MOTION was made by Billy Jordan, and duly SECONDED by E. L. Seay to set a fee of \$15.00 for the execution of an Extension of Lease. The President put the question and after full discussion and deliberation thereon, all members present voted "AYE". NONE voted "NO".
