The President of the Board called the Meeting to order, declared a quorum present, and that the Meeting was duly convened and ready to transact business.

The Minutes of April 17 were read and approved.

MOTION was made by Jearl Cooper, and duly Seconded by E. L. Seay, to approve Releases of Vencor's Liens to Cecil Franzina, Charles O'Neal, R. C. Swanner, and George Lester and to authorize the President and Secretary to execute same. The President put the question and, after full discussion and deliberation thereon, all members present voted "AYE". NONE voted "NO". A copy of each release will be attached hereto and made a part hereof.

Horris Morris reported as follows:

Complaint from McCoys in Snug Harbor concerning parties and litter adjacent to their lot. Mr. McCoy wanted to lease the property to keep the other people out.

Complaint concerning a trailer on the Loyd Rudolph lot in Snug Harbor in a residential area without a septic system.

Progress of picnic table construction.

Camper Site # 3 is available for use although dirt work is needed.

Texas Parks and Wildlife stated that they plan to do a survey on Lake Cypress Springs in 1979, and will set up a 5-year plan at that time.

The need for another tractor. The one tractor used by the District is kept busy with camper site construction and the construction of picnic tables and cannot be used for badly needed shredding.

The Board agreed that the Snug Harbor area adjacent to the McCoys should be left open. Mr. Morris was advised to keep a check on the litter problem.

Mr. Morris was instructed to advise Mr. Rudolph that the trailer would be moved out immediately or the District will confiscate it.

Homer Tanner and Traylor Russell informed the Board that they were merely meeting with the Board in an observation status. They were interested in the decision of the Board in regard to the proposed Amendment to the Cypress Basin Operating Plan. The President announced that the time had arrived to discuss the Amendment and to take the action deemed necessary by the Board. A "Resolution by the Board of Directors of the Franklin County Water District Approving the Amendment to Cypress Basin Operating Agreement" was submitted to the Board for consideration. The Resolution was read, approved and adopted and is attached hereto and made a part hereof.

Mr. Tanner and Mr. Russell retired from the Meeting.

The Board held a general discussion concerning some type of agreement between the District and Titus County for water sales downstream. No action was taken.

MOTION was made by Billy Jordan, and duly Seconded by E. L. Seay, to let the Minutes show that the motion made on April 17 approving the Amendment to the Cypress Basin Operating Plan was null and void because of the requirement of the bonding agent for a Resolution. The President put the question and all members present voted "AYE". NONE voted "NO".

The Board reviewed a list of Pending Items and Budget/Income Comparisons for the first three months of 1978.

There being no further business, the Meeting was adjourned.
