## MINUTES OF THE MEETING OF THE BOARD OF DIRECTORS OF THE FRANKLIN COUNTY WATER DISTRICT HELD: January 7, 1980

ON THIS the 7th day of January, 1980, the Board of Directors of the Franklin County Water District convened in Regular Session at their office located at 114 North Houston Street on the East side of the square in Mount Vernon, Texas, with the following members present:

The President of the Board called the Meeting to order, declared a quorum present, and that the Meeting was duly convened and ready to transact business.

The Board convened in an extended executive session which lasted well over into the afternoon, after which the following action was taken.

MOTION was made by Ennis Christenberry, and SECONDED by E. L. Seay, to purchase a police scanner for use by the Lake Superintendent. The President put the question and, after full discussion and deliberation thereon, all members present voted "AYE". NONE voted "NO".

The Board instructed the Lake Superintendent to advise the Maintenance Personnel that they were to ride to and from work in the same vehicle if at all possible.

MOTION was made by E. L Seay, and SECONDED by Billy Jordan, to approve the purchase of a depth finder for the boat. The President put the question and, after full discussion and deliberation thereon, all members present voted "AYE". NONE voted "NO".

Approval was given for the purchase of two (2) <sup>1</sup>/<sub>2</sub> hand drills.

MOTION was made by Billy Jordan, and SECONDED by Jearl Cooper, to repair and restore the barge, and to install a winch and gin pole on same. The President put the question and, after full discussion and deliberation thereon, all members present voted "AYE". NONE voted "NO".

A Resolution was adopted to advertise for bids on two Suburbans. Said resolution is attached hereto and made a part hereof.

The Board reviewed bids on a boathouse, but no action was taken.

There being no further business, the meeting was adjourned.
