MOTION was made by Elwyn Carr, and SECONDED by Bill Elliston, to ratify action taken in paying bills since the last meeting. The President put the question and, after full discussion and deliberation thereon, all members present voted "AYE". NONE voted "NO". A list of the bills is attached hereto and made a part hereof.

MOTION was made by Billy Jordan, and SECONDED by Elwyn Carr, to adopt a RESOLUTION providing for the extension of the South Franklin Water Supply Corporation's Water Purchase Contract. The Resolution is attached hereto and made a part hereof.

The Board was advised that the Texas Water Commission will no longer be making inspections on the dam. They have agreed to inspect it this year but we will be required to have the inspection done at District expense in the future.

MOTION was made by Bill Elliston, and SECONDED by Edson Reynolds, to approve the execution of a "Ratification of Easement and Right-Of-Way" to Wood County Electric for a line extending into Pelican Bay. The President put the question and, after full discussion and deliberation thereon, all members present voted "AYE". NONE voted "NO". A copy of the Ratification is attached hereto and made a part hereof.

The Board convened in Executive Session to discuss the contract of the Water District Manager.

In open session MOTION was made by Bill Elliston, and SECONDED by Elwyn Carr, to renew the Manager's Contract for five (5) years. The President put the question and, after full discussion and
