The President called the meeting to order, declared a quorum present, and that the meeting was duly convened and ready to transact business.

Notice of this meeting was given, stating the time, place and purpose, all as required by Chapter 551 of the Government Code.

A moment of silence was recognized.

No one spoke during Public Comment.

MOTION was made by Billy Jordan, and SECONDED by Carmen Sparks, to approve the consent agenda as amended. Motion carried unanimously. The Consent Agenda was as follows:

At this time, the President closed the regular meeting to go into the public hearing on the District's proposed 2020 tax rate for debt service. The public made no comments and the board closed the public hearing and went back into regular session.

MOTION was made by Billy Jordan, and SECONDED by Carmen Sparks, to adopt the 2020 tax rate for debt service at \$0.018 per \$100 of value. Motion carried unanimously.

The Board discussed amending the District Rules and Regulations regarding Article 4, Hunting and Fishing, Article 5, Boats, Aircraft, Automobiles, Bicycles, and Other Vehicles, and Article 15, Construction on District Property, to comply with Texas Parks and Wildlife Department requirements. The following members of the public spoke: Greg Monson, Mike Rambin, Roy Hardin, Jim Greenwood and Billy Robertson. MOTION was made by Carmen Sparks, and SECONDED by Billy Jordan, to submit the District's current adopted Rules and Regulations and the current official buoy placement map to Texas Parks and Wildlife for their review. Motion carried unanimously.
